1. Grant of License

Licensors hereby grants to Licensee a non-exclusive, non-transferable license to use the licensed beat (the “Beat”) solely for the purposes described herein and subject to the terms and conditions of this Agreement.

2. Ownership

Licensors retains all right, title, and interest in and to the Beat, including all copyrights and other intellectual property rights. Licensee obtains no ownership interest in the Beat by virtue of this Agreement.

3. Permitted Uses

Licensee may use the Beat for synchronization in audio recordings, performances, and digital streaming, provided such uses comply with the scope of the license granted. Licensee shall not use the Beat in any unlawful manner or in a manner that infringes upon third-party rights.

4. Restrictions

Licensee shall not sublicense, distribute, resell, or otherwise make the Beat available to any third party except as expressly permitted herein. Licensee shall not create derivative works from the Beat without prior written consent from Licensors.

5. Payment

Licensee agrees to pay Licensors the License Fee as specified above. Payment shall be made in full prior to Licensee’s use of the Beat. No refunds shall be provided once the Beat has been delivered.

6. Warranties and Disclaimers

Licensor represents that it has the right to grant this license. The Beat is provided "AS IS," without warranties of any kind, whether express or implied, including but not limited to warranties of merchantability, fitness for a particular purpose, or non-infringement.

7. Indemnification

Licensee agrees to indemnify, defend, and hold harmless Licensor from and against any claims, damages, liabilities, costs, and expenses arising out of Licensee's use of the Beat, including any breach of this Agreement.

8. Term and Termination

This Agreement is effective as of the Effective Date and continues indefinitely unless terminated as provided herein. Licensor may terminate this Agreement immediately if Licensee breaches any material term. Upon termination, Licensee shall cease all use of the Beat.

9. Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with the laws of the United States of America and the State of _____. The parties consent to exclusive jurisdiction and venue in the federal and state courts located in _____ County, _____.

10. Entire Agreement

This Agreement constitutes the entire agreement between the parties regarding the Beat license and supersedes all prior or contemporaneous understandings or agreements, whether written or oral.

11. Amendments

Any modification or amendment of this Agreement must be in writing and signed by both parties. No waiver of any provision shall be effective unless in writing and signed by the party granting such waiver.

12. Severability

If any provision of this Agreement is found to be unenforceable or invalid, such provision shall be severed and the remainder of the Agreement shall remain in full force and effect.

13. Assignment

Licensee may not assign or transfer this Agreement or any rights granted hereunder without the prior written consent of Licensor.

14. No Waiver

No failure or delay by either party in exercising any right shall operate as a waiver of such right or any other rights under this Agreement.

15. Headings

Headings used in this Agreement are for convenience only and shall not affect the interpretation of any provision.

16. Counterparts and Electronic Signatures

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one instrument. Electronic signatures shall have the same force and effect as original signatures.
