Warranty Terms and Conditions:

1. Warranty Coverage: The Warrantor hereby extends to the Warranty Holder an extended warranty covering the Product described above. This warranty covers defects in materials and workmanship under normal use and service during the Warranty Period. 2. Warranty Period: The warranty period shall commence immediately upon expiration of the original manufacturer's warranty and shall remain in effect for the specified extended duration as defined in the attached Schedule. 3. Warranty Exclusions: This warranty does not cover damages or defects caused by accident, misuse, abuse, neglect, unauthorized alterations or repairs, normal wear and tear, or any use inconsistent with product instructions. 4. Claims Procedure: Warranty Holder must notify Warrantor promptly in writing of any defect or malfunction. Warrantor reserves the right to inspect the Product and requires reasonable access to facilitate inspection and repair. 5. Remedies: Upon validation of a warranty claim, the Warrantor shall, at its sole discretion, repair or replace the defective Product or component, or refund the purchase price. Replacement parts or products may be new or equivalent in performance. 6. Limitation of Liability: The Warrantor's liability under this warranty is limited to the terms expressed herein. In no event shall the Warrantor be liable for incidental, consequential, or special damages, including loss of use, loss of profits, or commercial loss. 7. Transferability: This extended warranty is transferable/not transferable (select one) in accordance with the terms specified in the attached Schedule. 8. Governing Law: This Agreement shall be governed by and construed under the laws of the state specified in the Governing Law section herein, without regard to conflict-of-law principles. 9. Entire Agreement: This Agreement constitutes the entire agreement between the parties with respect to the extended warranty and supersedes all prior discussions, agreements, or understandings of any kind. 10. Amendments: No amendment or modification of this Agreement shall be valid unless in writing and signed by both parties. 11. Severability: If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect. 12. Notices: All notices under this Agreement must be in writing and delivered by hand, certified mail, or nationally recognized overnight courier to the addresses provided herein. 13. Dispute Resolution: Any disputes arising out of or relating to this Agreement shall be resolved through binding arbitration in the venue specified in the Governing Law section, pursuant to the rules of the American Arbitration Association. 14. Waiver of Jury Trial: To the maximum extent permitted by law, each party

knowingly and voluntarily waives any right to a trial by jury in any dispute arising out of or relating to this Agreement. 15. Force Majeure: Neither party shall be liable for failure or delay in performance due to causes beyond their reasonable control, including acts of God, war, terrorism, labor disputes, or governmental actions. 16. Indemnification: Warranty Holder agrees to indemnify and hold harmless the Warrantor from any claims, damages, or liabilities arising out of misuse or unauthorized modification of the Product. 17. Cancellation: This Agreement may be cancelled subject to the terms and conditions outlined in the attached Schedule. 18. Counterparts and Electronic Signatures: This Agreement may be executed in counterparts and signed electronically, each of which shall be deemed an original and all of which constitute one Agreement.

Miscellaneous:

This Extended Warranty Agreement is binding upon and inures to the benefit of the parties hereto and their respective successors and permitted assigns. No party may assign or transfer any rights or obligations under this Agreement without the prior written consent of the other party, except in the case of a merger, acquisition, or sale of substantially all assets. The failure of either party to enforce any provision of this Agreement shall not constitute a waiver of that provision or any other provision. If any provision is held invalid, illegal, or unenforceable, the remaining provisions shall remain valid and enforceable.
