Purpose and Scope of Agreement:

This Agreement outlines the terms and conditions under which the Caregiver agrees to provide care and assistance to the Care Recipient. The Caregiver shall perform services as detailed below and comply with all applicable laws and regulations governing such care.

Caregiver Duties and Responsibilities:

The Caregiver agrees to provide personal care, companionship, and assistance with daily living activities including but not limited to: medication reminders, meal preparation, housekeeping, transportation to appointments, and other tasks mutually agreed upon. Compensation:

The Caregiver shall be compensated at the rate agreed upon by both parties. Payment schedule, method, and any reimbursements for expenses shall be clearly outlined and agreed upon separately.

Term and Termination:

This Agreement shall commence upon execution and continue until terminated by either party with prior written notice. Immediate termination may occur for cause, including but not limited to breach of this Agreement, neglect, or misconduct.

Confidentiality:

The Caregiver agrees to maintain the confidentiality of all personal, medical, and financial information pertaining to the Care Recipient, except as required by law or with the Care Recipient's express consent.

Indemnification and Liability:

The Caregiver shall perform services to the best of their ability and is not liable for events beyond their control. The Care Recipient agrees to indemnify and hold harmless the Caregiver from any claims arising from services provided under this Agreement, except in cases of gross negligence or willful misconduct.

Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the United States and the applicable state laws without regard to its conflict of laws principles.

Dispute Resolution:

The parties agree to attempt to resolve any disputes arising under this Agreement through good faith negotiation. If resolution cannot be reached, disputes shall be resolved in the appropriate state or federal courts as agreed herein.

Entire Agreement:

This Agreement constitutes the entire understanding between the parties with respect to the subject matter and supersedes all prior agreements, representations, and understandings, whether oral or written.

Amendments:

No amendment or modification of this Agreement shall be valid unless in writing and signed by both parties.

Severability:

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Acknowledgment:

Both parties acknowledge that they have read and understood this Agreement, have had the opportunity to seek independent legal counsel, and agree to be bound by its terms.
