## Terms and Conditions:

This Refund Agreement (the "Agreement") sets forth the terms and conditions under which the Refundor agrees to refund the specified amount to the Refundee. Both parties agree to the following clauses which are legally binding and enforceable under the laws of the United States of America.

### Clause 1 – Refund Amount and Payment

The Refundor shall pay the Refundee the total refund amount specified above. Payment shall be made via wire transfer, cashier's check, or other mutually agreed upon method within the timeframe agreed upon by the parties.

### Clause 2 – Release of Claims

Upon receipt of the refund amount in full, the Refundee agrees to release and discharge the Refundor from any and all claims, demands, actions, or liabilities related to the subject matter giving rise to this refund.

### Clause 3 – Representations and Warranties

Each party represents and warrants that they have the full right, power, and authority to enter into this Agreement and perform their obligations hereunder.

### Clause 4 – Confidentiality

The terms of this Agreement and any information exchanged shall be kept confidential by both parties except as required by law or with prior written consent.

### Clause 5 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the United States of America without regard to its conflicts of law principles. Any disputes arising shall be subject to the exclusive jurisdiction of the federal or state courts located within the appropriate venue.

### Clause 6 – Entire Agreement

This Agreement constitutes the entire agreement between the parties regarding the refund and supersedes all prior or contemporaneous communications, understandings, or agreements, whether oral or written.

### Clause 7 – Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties.

**Clause 8 – Severability**

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

**Clause 9 – Counterparts**

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.

**Clause 10 – No Admission of Liability**

This Agreement and the payment of the refund shall not constitute an admission of liability by the Refundor.

**Clause 11 – Notices**

All notices under this Agreement shall be in writing and delivered by hand, certified mail with return receipt requested, nationally recognized overnight courier, or by electronic means with confirmation of receipt.

**Clause 12 – Force Majeure**

Neither party shall be liable for failure or delay in performing its obligations due to events beyond their reasonable control, including but not limited to acts of God, war, terrorism, labor disputes, or government actions.

**Clause 13 – Waiver**

No waiver of any breach or default hereunder shall be deemed a waiver of any preceding or subsequent breach or default.

**Clause 14 – Assignment**

Neither party may assign or transfer its rights or obligations under this Agreement without the prior written consent of the other party.

**Clause 15 – Relationship of Parties**

Nothing contained herein shall be construed as creating any partnership, joint venture, or agency relationship between the parties.

**Clause 16 – Headings**

Headings in this Agreement are for reference only and shall not affect the interpretation of any provisions.

**Clause 17 – Execution**

The parties have caused this Agreement to be executed by their duly authorized representatives as of the Effective Date.
