Use and Maintenance:

Lessee agrees to use the Equipment in a careful and proper manner and comply with all applicable laws and regulations. Lessee shall maintain the Equipment in good condition, reasonable wear and tear excepted, and shall not make any alterations without prior written consent of Lessor.

Liability and Insurance:

Lessee assumes all risk of loss, theft, damage, or destruction of the Equipment from the time of delivery until return to Lessor. Lessee shall maintain insurance coverage satisfactory to Lessor covering loss or damage to the Equipment and liability arising from its use, naming Lessor as an additional insured where applicable.

Indemnification:

Lessee agrees to indemnify, defend, and hold harmless Lessor from any claims, damages, losses, liabilities, costs, and expenses arising out of or related to Lessee's use or possession of the Equipment, except to the extent caused by Lessor's gross negligence or willful misconduct.

Return of Equipment:

Lessee shall return the Equipment to Lessor at the agreed location in the same condition as received, ordinary wear and tear excepted, on or before the end of the Rental Period. Failure to timely return the Equipment shall subject Lessee to additional charges and liability for loss or damage.

Default and Remedies:

If Lessee fails to pay any amounts due or otherwise breaches this Agreement, Lessor may terminate the rental, repossess the Equipment, and pursue all legal and equitable remedies. Lessee shall be liable for all costs and expenses incurred by Lessor in enforcing its rights.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the state where the Equipment is rented. Any disputes arising shall be subject to the exclusive jurisdiction and venue of the courts located in the county of Lessor's principal place of business.

Entire Agreement and Amendments:

This Agreement constitutes the entire agreement between the parties concerning the rental of the Equipment and supersedes all prior agreements. Any amendments must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Notices:

All notices under this Agreement shall be in writing and deemed given upon delivery by hand, certified mail return receipt requested, nationally recognized overnight courier, or by electronic transmission confirmed by sender.
