Clause 1 – Agreement to Sell and Purchase

Seller agrees to sell and Buyer agrees to purchase the vehicle identified above (the “Vehicle”) on the terms set forth herein. Seller represents full authority to sell and transfer ownership of the Vehicle.

Clause 2 – Vehicle Condition; AS-IS

The Vehicle is sold AS-IS, WHERE-IS, with all faults and without any warranties, express or implied, including but not limited to warranties of merchantability or fitness for a particular purpose. Buyer has had the opportunity to inspect the Vehicle and accepts its condition subject only to rights provided in this Agreement.

Clause 3 – Title and Ownership

Seller warrants that it is the lawful owner of the Vehicle, the Vehicle is free from liens and encumbrances except as disclosed, and Seller will provide the necessary documents to transfer title to Buyer.

Clause 4 – Delivery

Risk of loss or damage passes to Buyer upon delivery of the Vehicle. Delivery location and date shall be mutually agreed upon by the parties.

Clause 5 – Payment

Buyer shall pay the Purchase Price in full by the agreed method and schedule. Seller reserves the right to retain possession of the Vehicle until full payment is received.

Clause 6 – Odometer Disclosure

Seller certifies that the odometer reading stated above reflects the actual mileage of the Vehicle unless otherwise noted.

Clause 7 – Taxes and Fees

Buyer is responsible for all applicable taxes, registration fees, and other charges associated with the transfer of ownership and operation of the Vehicle.

Clause 8 – Notices

Any notices required under this Agreement shall be in writing and delivered by hand, certified mail, overnight courier, or electronic means with confirmation of receipt.

Clause 9 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflict of law principles. The parties consent to the exclusive jurisdiction and venue of the state or federal courts located in _____ County, _____.

Clause 10 – Entire Agreement

This Agreement constitutes the entire agreement between the parties relating to the Vehicle sale and supersedes all prior discussions, negotiations, and agreements.

Clause 11 – Amendments

No amendment or modification of this Agreement will be effective unless in writing and signed by both parties.

Clause 12 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

Clause 13 – Waiver

Failure to enforce any provision shall not be deemed a waiver of future enforcement.

Clause 14 – Binding Effect

This Agreement shall be binding upon and inure to the benefit of the parties and their respective heirs, successors, and assigns.

Clause 15 – Counterparts and Electronic Signatures

This Agreement may be executed in counterparts and by electronic signature, each of which shall be deemed an original but all of which together constitute one and the same instrument.

Clause 16 – Default and Remedies

In the event of default by either party, the non-defaulting party may pursue all remedies available at law or in equity.

Clause 17 – Representations and Warranties

Each party represents that they have the full power and authority to enter into this Agreement.

Clause 18 – No Other Representations

Buyer acknowledges that no representations have been made except those expressly set forth in this Agreement.

Clause 19 – Risk of Loss

Risk of loss or damage to the Vehicle passes to Buyer upon delivery.

Clause 20 – Signatures

The parties have executed this Agreement as of the date indicated above, intending to be legally bound.
