### 1. Purpose

This Voluntary Child Support Agreement (the "Agreement") is made by and between the parties named above for the purpose of establishing the terms and conditions of child support for the minor child(ren) named herein. This Agreement is intended to be legally binding and enforceable under the laws of the United States.

### 2. Child Support Amount

### 3. Duration of Support

### 6. Modification

This Agreement may be modified only by a written agreement signed by both parties or by court order. Any change in circumstances substantially affecting child support shall be grounds for modification.

**7. Enforcement**

Failure to comply with the terms of this Agreement may result in enforcement actions including, but not limited to, wage garnishment, interception of tax refunds, suspension of licenses, and other remedies allowed by law.

**8. Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_, without regard to its conflict of laws principles.

**9. Entire Agreement**

This Agreement constitutes the entire understanding between the parties relating to child support and supersedes any prior agreements or understandings, whether written or oral.

**10. Severability**

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

**11. Voluntary Execution**

Each party acknowledges that they have read this Agreement, understand its terms, and are entering into it voluntarily and without duress. Each party has had the opportunity to seek independent legal advice.
